

# Coronavirus Information, Resources & Considerations For Services During School Shutdown

## Practice Considerations:

If you are providing services while school is out of session, then you should have a discussion with your special education directors and supervisors about:

- What are your professional/ethical obligations at this time?
- What are your legal obligations at this time?
- What services should and should not be provided at this time?
- What permissions need to be obtained?
- What modalities should be used to deliver services?
  - an alternate location/in the home?
  - the provision of online or virtual instruction?
  - instructional telephone calls?
  - other curriculum-based instructional activities?
  
- If on-line services are chosen, what platform should be chosen?
  - Are they HIPAA and FERPA Compliant?
  - Has the district entered into a Business Associates Agreement with the provider?
  - Does the platform reasonably ensure that electronic social work services can be kept confidential?
  
- Where will you work to guarantee the student's privacy?
- What type of documentation should be maintained?
- What type of technology does the student have and how will the district provide them with technology if they do not have what is needed?
- Will you attempt to bill Medicaid? (This may not be billable- waiting for guidance from the state- an email will be sent.)
